2. Notes from Nationals:

- a. All Teacher Candidates (Elementary, Intermediate, Advanced and Diploma) for exams must submit a Sponsor letters from their Sponsor. A Sponsor letter is a simple letter stating that the coach is willing to sponsor the candidate.
